Course Description

Psychology is a scientific discipline. This course will introduce you to the application of theory and research in psychology to the etiological factors of violence against women and children, in addition to possible intervention and prevention approaches.

Course Objectives

Upon completion of this course, students will be able to:

- 1. Apply theoretical models of violence to violence against vulnerable populations.
- 2. Use critical thinking skills to evaluate research findings and their application to violence against vulnerable populations.
- 3. Understand the role of psychological factors in the etiology and prevention of violence against vulnerable populations.
- 4. Identify disparities in violence that have been associated with ethnicity, gender, and sexual orientation.
- 5. Effectively communicate orally and in writing an in-depth knowledge of violence against vulnerable populations.

Course Expediations

Please talk with the professor if you would like additional assistance.

Add/Drops & Incompletes: The University add/drop and incomplete grade policies will be explicitly followed. It is the student's responsibility to be aware of the University deadline dates for dropping the course. Incompletes (grades of "I") will be given only in the case of unavoidable medical emergencies (e.g., written note from doctor), and not if you are failing the course.

Class attendance: You are graduate students and are responsible for your own professional conduct which will contribute to your academic career and development. Readings: You are required to read the articles posted on Moodle. This will help you to actively participate in class discussions and activities.

Class Participation (10%): The format of this course is a graduate-level seminar. That is, it will consist of some lecture along with class discussion. It is essential that everyone come to each class prepared to discuss the assigned readings. If you miss class, then you obviously will be unable to participate in the class discussion and will not receive points that day.

Facilitation of Discussion (20%): Each student will lead one class session this semester (depending on final enrollment). You are expected to be well-prepared and lead discussion about the assigned readings. You are also required to find additional empirical articles to supplement the assigned reading. The reading(s) you choose should be directly related to the topic and expand upon the theories discussed in the class. You will need to provide a citation or a copy of the .pdf to your classmates (and me) at least one week prior to the class session that you are assigned to facilitate.

Violence against Vulnerable Populations Measurement Paper (20%): You will be expected to write one APA-style paper (3-5 pages) that identifies the best possible measurement tool for your topic (you may choose violence against any vulnerable population using any theoretical approach you wish). Your paper should define/operationalize the type of violence you choose, and make an argumentative case as to why the measure you chose is superior to other measures of that particular type of violence. You should use measurement literature that identifies and examines/measures reliability and validity to make your case. Your paper will be graded based on the clarity of presentation, flow of ideas, use of empirical support and the development of the topic. You will be required to use APA format. You will not specifically be graded on format, spelling or grammar; however, if these issues interfere with the readability of your paper, points will be deducted.

Intervention Proposal (30%): You will propose an empirical investigation of a topic discussed in class. This intervention proposal should be unique and not one that you may have used in another course. The proposal should be approximately 10-15 pages in length (not including title page, abstract, or references) and should be in APA-format. Your proposal should include at least 20 references (you may use readings assigned for class). If you are unfamiliar with how to compose a research proposal, make sure to discuss this with me or your peers.

The purpose of your proposal is to propose an intervention in which you seek to reduce violence in a domain of your choosing using one or more of the theories discussed in this course. You will want to define and operationalize the violence behavior you choose. The theory and violence behavior you choose must be supported by the literature and I expect your literature review to be fairly extensive- not only in arguing why your theory/method is the best but also why other theories/methods do not work. You should also include a methods section that identifies a population, presents the procedures, and measures/methods of assessment and change. This section should also be supported by literature. Your paper will be graded based on the clarity of presentation, flow of ideas, use of empirical support, and the development of the topic. You will not specifically be graded on format, spelling or grammar; however, if these are issues interfere with the readability of your paper, points will be deducted.

Formal Presentations (20% of grade; 10% each): You will deliver two presentations (20-25 minutes each) based upon the paper topics described above. Your presentation will occur before the papers are due and you will be able to use the feedback and questions from your classmates and me to refine your paper before turning it in for grading. You will turn in a copy of your presentation slides to my prior to your presentation.
